

# 2026 Members' Juried Show

March 6 - April 24, 2026

---

*The Art Center would like to encourage all Artist Members to enter their artwork in this annual exhibit, displayed within both the Whiting and Woolley Galleries.*

**Eligibility:** This show is open to all Artist Level Members and above of the Eastern Shore Art Association.

**Artworks:**

- Members may submit up to three original works done in any media.
- If submitting 2-3 works, no piece may exceed 40 inches in any direction including frame.
- Alternately, one large work may be submitted not to exceed 2400 square inches total, with a maximum width of 60."
- Artwork must have been created within the last 12 months. Must be original work (not created within an ESAC training workshop).
- Works CANNOT have been exhibited at ESAC previously.
- Entries must be properly framed or gallery-wrapped, wired and suitable for hanging.
- Works on paper must be under plexiglass or glass.
- Three-dimensional pieces must not weigh more than can be handled by two people.
- Each entry must be accompanied by a registration tag, completely filled out and signed, with the appropriate part attached securely to the back of each entry.
- Entry forms will be available at the front desk, online at <https://esartcenter.org> until the day of registration, Saturday, February 28 or at the registration table.

**Entry Date:** Entries for jurying will be received Saturday, February 28 between 10 am and 6 pm. Due to a shortage of storage space, works cannot be accepted before this date. *One piece \$25, second piece \$10 and third piece \$10.* Notification of acceptance into the show will be done via email or phone by Tuesday, March 3. Work not accepted into the show can be picked up Wednesday, March 4 or Thursday, March 5 between 10 am and 4 pm. Jury fees are non-refundable.

**Awards/Reception:** Awards will be given out during Art Walk, March 6 at 6:30 pm.

*Best In Show: \$500   First Place: \$300   Second Place: \$200   Awards of Merit (3): \$100 each*

**Removal:** The exhibit closes Friday, April 24 and no work may be removed from the show until then (without permission of the artist and/or ESAC staff). Works must be picked up no later than Saturday, April 25.

**Sales:** The Eastern Shore Art Association will receive a 30% commission on the sale of works initiated during the show.
